Violation #32. Ice

Repair or replace the ice maker machine.

CODE REFERENCE: Ice. 64E-11.004(19). Ice brought into the facility will be from an approved source.

Violation #37. Garbage disposal

Replace the damaged 6 Cu. Yd. outdoor garbage dumpster. The bottom is corroded at the front end. The floor underneath can be seen from inside the empty dumpster through the gap that runs all along the front (potential leaking condition).

CODE REFERENCE: Garbage. 64E-11.007(6). Garbage will be disposed of to prevent vector harborage. Garbage containers will be leak proof. Outside storage will be on top of a smooth nonabsorbent material.
