<p>Violation #23. Date marking and disposition Observed containers with scramble eggs and veggie burgers stored at reach in refrigerator without proper date marked. Provide date marked to food prepared in facility and held over 24 hours. COS. Marked date was placed at containers. CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are RTE and held refrigerated for more than 24 hours, shall be properly date marked unless otherwise exempted.</p>
<p>Violation #54. Garbage & refuse disposal Observed missing drain plug at garbage dumpster. Provide drain plug. Observed open lids at garbage dumpster. Close lids to prevent vector harborage. CODE REFERENCE: 64E-11.003(5). Garbage shall be disposed of to prevent vector harborage. Trash cans will be durable, cleanable, leak proof, insect and rodent resistant, and non-absorbent. Outside storage area shall be of a smooth, non-absorbent material and sloped to a drain.</p>
